

### Important notices

### Upgrade requirements

Upgrade requirements for specific software products are as follows:

- TRAKiT.Net requires .NET framework 4.0
- CentralSquare Mobiles and eTRAKiT users require IIS with .NET framework 4.6.1

#### Installing updates

To install updates, run the following installation programs:

- 1. Run TrakitRuntime.exe. This program installs updates that support changes to third-party systems.
- 2. Run TRAKiT Server Update.exe. This program installs the TRAKiT.Net release changes.

The installation also requires downloading the Microsoft OLE DB Driver for SQL Server to your database server and, in your web.config file for all .NET applications, changing the SQL Provider from SQLOLEDB to MSOLEDBSQL. The CentralSquare Installation team makes these updates.

### Map support

Esri discontinued support for MapObjects integration for Esri maps. You must use the TRAKiT.Net Silverlight integration for displaying maps. If you currently use MapObjects, contact the CentralSquare support team to request assistance in migrating to Silverlight for displaying maps. TRAKIT.Net and Silverlight are quality-tested using .NET framework 4.0.

- Resolved an issue with the application attachments disclaimer pop-up message to prevent duplicate attachments from being added. (Case 01831864, SR 1007217)
- Resolved an issue that caused WorkSpace to take a long time to load when you had many filters set in any pane. (Case 01578027, Case 01762906, SR 593170)
